2) For a chance to win a prize (cash, property or other special advantage)
3) The winner of which is determined by chance

## PRIZE PROGRAM COMPLIANCE WITH PA GAMBLING LAW

From time to time, student organizations and departments may consider offering contests and prizes in order to encourage participation in a campus program or as part of a student entertainment event. University policy governs all decisions regarding the appropriate use of University resources to support such programs. State and federal regulations govern the way in which prize programs can be conducted and reported. Prizes may be awarded to University employees and students if supported by a valid institutional purpose and with prior approval.

As a guideline for groups considering a prize program, the following structures may be offered to Lehigh students, faculty and staff in compliance with the terms of the Pennsylvania Gambling Law. Please note that under <u>all</u> structures, tax reporting/remittance may be required.

- 1) Prizes for winning a game of skill. Participants must not make a financial contribution to "the prize pool". For example:
  - video games
  - board games
  - trivia contests
  - free-throw contests
  - "Minute to win it" types of contests

Please note that poker, Texas hold'em, and other card games are considered by PA courts to be predominately chance, not skill. However, they can still be done provided that there is no entry fee or "buy in" to participate.

2) Door prizes or raffles for attendees/participants in a program. Participants must not be required to purchase a chance to win and do not need to be present to win.

For example:

- a prize for the 100<sup>th</sup> customer
- to encourage/thank participants for attendance at an event, all attendees receive a ticket and name(s) is/are randomly selected at the end of the program to win a prize
- to encourage/thank participants for completing a survey, participant(s) names is/are randomly selected at the conclusion of the survey to win a prize (no purchase required)

## PRIZE PROGRAMS THAT ARE NEVER ALLOWABLE

- 1) Bingo
- 2) Sporting (football, basketball, etc) pools that require a financial contribution
- 3) Any game of chance or contest that that is not based upon skill and requires a financial contribution to participate
